a message from the President & CEO of the SU Foundation

Dear Ship Family,

Thank you for your philanthropy this past fiscal year which made it possible for another record-setting year at the Shippensburg University Foundation. Not only were total contributions the highest in SU Foundation history, but also surpassed the 10-million-dollar mark for the first time ever — **\$10,061,905**. Last year's fundraising amount was previously the highest amount raised in SU Foundation history-**\$8,925,249**.

The Annual Fund also had a record-breaking year with contributions totaling **\$3,145,452**. We thank our National Annual Fund Co-Chairs, David '80 and Laurie '79&'86M Morgan, and their leadership team for their great work inspiring alumni and friends to support Ship students.

We are pleased to share with you the Shippensburg University Foundation's 2022-2023 Annual Impact Report which tells the stories of benefactors, like you, who are making an impact on students and the stories of Ship students who are taking full advantage of the opportunities you and thousands of other donors are providing for them and other students. This Impact Report should also convey to you our sincere thanks and appreciation for responding to the call to help Ship students receive a quality education.

Your gifts support hundreds of funds held by the SU Foundation unrestricted funds, funds for scholarships, textbooks, student emergencies, engineering and scientific equipment, athletics, and the library to name a few. The Foundation's Student Emergency Fund, which was established in November 2020 during COVID, has provided over \$84,000 in grants to students in need of assistance with tuition, food, housing, and textbooks. The signature Joint Undergraduate Student/Faculty Research program gives students a competitive edge when applying for graduate school or jobs in their field. The Wood Honors College offers enriching experiences for talented Shippensburg University students, with an emphasis on scholarship, leadership, and service. Studying abroad helps students become more versatile, both professionally and personally in a rapidly developing global society.

Other significant numbers highlighted in this Impact Report are worth further mention—the SU Foundation's endowment is at its highest level ever, over \$57 million at June 30, 2023, resulting from a combination

of positive investment returns and donor gifts. The SU Foundation provided \$7.89 million in direct and indirect support for the benefit of Shippensburg University's students, faculty, and programs this past year.

While the dollar amounts are impressive, what is most impressive is what is accomplished with these funds from our wonderful benefactors, like you, that directly benefit Ship students now and in the future. Giving back is a tradition at Ship and a way to say thank you for an outstanding education, unique and countless opportunities, and lasting friendships.

The SU Foundation awarded 663 academic and athletic scholarships to Ship students last year totaling a record \$2,067,096. Scholarships provide a passport to a world of opportunities for talented and deserving students. The students featured in this annual report share their stories with us and how important the funds they received for scholarships, study abroad, and undergraduate research led by faculty are to their success at Shippensburg University.

While not a goal of the SU Foundation, you may be interested in knowing how the Foundation measures up in raising charitable dollars with other Pennsylvania State System universities. For the most recent reporting information available from fiscal year 2021-2022, our Foundation was second among PASSHE schools in total giving, trailing first place by only \$127,000. The SU Foundation was first in alumni giving, giving to student financial aid, and giving to athletics. We were second in parent giving and unrestricted giving. The \$10,061,905 that we raised this past year may possibly lead all PASSHE universities when the final numbers are available in February.

Our university must remain strong and vital for our region and for the students we want to serve. Through the Shippensburg University Foundation, we must also be able to support the needs of the students and faculty through private charitable dollars.

Thank you for continuing to make a difference in the lives of Ship students and thank you for having such a giving spirit.

Dear Shippensburg University family and friends,

As I write this letter and reflect on all that we have accomplished at Shippensburg University over the last two years, I am humbled and thankful for the support of our benefactors.

Our accomplishments are the result of a mutual love for Ship and the students we serve. Our Ship students aspire to greatness, and their success is made possible by our dedicated faculty, staff, alumni, and the work of the SU Foundation, its donors, and friends like you. The information that follows is only a few of our collective accomplishments, but highlights the intersection of where students are engaged in the scholarly activity of our faculty and campus community.

With a transformational gift and the dedication of the Milton and Doreen Morgan School of Engineering and Engineering Laboratory, we've made our mark as the emerging premier engineering school in our region. We continue to engage with employers and corporate partners to provide well-curated pathways for students and to provide hands-on learning opportunities along the way.

This past year, students, with the support of the SU Foundation and Volvo, competed on an international level with their buggy prototype at the SAE Baja. This intercollegiate competition is sponsored by the Society of Automotive Engineers and allows our students to compete and enhance their craft. They are already hard at work preparing for next year's competition. It's meaningful projects like this, driven by collaboration with our corporate partners, that enhance student learning and advance real-world applications in the field of engineering. Our continued relations with JLG Industries also saw several engineering students interning at various locations this summer in the areas of software engineering, digital technology, and mechanical design.

Our nearly 450 student-athletes are setting the bar high on the field and in the classroom with support from the Kathryn Hughes Seaber Raiders Academic Center for Student-Athletes (Seaber RAC). This past spring, over half of our student-athletes earned a 3.0 or higher and 139 earned a spot on the Dean's List with a 3.5 or higher for the semester.

The Charles H. Diller Jr. Center for Entrepreneurial Leadership and Innovation continues to provide a space for aspiring entrepreneurs to learn, explore, and test their ideas. This past year the center hosted its annual Ship Tank pitch contest, introduced a new speaker series featuring alumni entrepreneurs, hosted high school students for an entrepreneur competition, and so much more. The center impacted 550 students in the last academic year and is on course to reach more students this year!

Thanks to the continued support of the SU Foundation and unrestricted donor contributions, student research was once again front and center this past academic year with our annual Minds@Work Student Research Conference. In the spring, the SU Foundation provided financial support to send nine chemistry students to the National Meeting of the American Chemical Society. Students took second place in the Division of Agricultural and Food Chemistry poster competition highlighting their scholarly research, a very prestigious accomplishment for our Ship undergraduate students.

And as we look to the future, your continued support is needed to further even more exciting opportunities through the transformation of two existing and historic buildings to support entrepreneurship and the sciences at Ship.

The planned renovation of Kriner Hall will create an entrepreneurial hub housing the Charles H. Diller Jr. Center for Entrepreneurial Leadership and Innovation, the Milton K. Morgan III Makerspace within the Diller Center, and the region's Small Business Development Center. When coupled with our proposed Small Business Internship Initiative, this entrepreneurial hub will create a dynamic one-stop-shop to empower students, faculty, and community members to develop the necessary skills to start or grow a small business, resulting in increased economic development for one of the fastest growing regions in Pennsylvania. The entrepreneurial hub will promote critical opportunities for innovation in the university community and throughout South-Central PA's growing region by providing resources, education, co-working space, and access to a network of established businesses and investors for beneficial opportunities for collaboration and partnership.

As science and technology progress, so do the needs of students, educators, and researchers. Today's science buildings must respond to changing teaching methodologies and new technologies. The laboratory of the future is constantly in flux, and we continue to make efforts to advance the renovation of the Franklin Science Center complex to provide more flexible and adaptable facilities that can accommodate changing teaching methods, allow modern research and scholarly pursuits, and more easily adapt to future needs and flexible learning environments. The redesign of Franklin Science Center requires both sensitivity and balance as we plan for spaces that meet current needs and allow for both anticipated and unanticipated future requirements.

Again, I am humbled by all that we've accomplished and the support of our Ship Family and friends. I look forward to what's next and am confident that, together, we are building a bright future for Ship.



2020-2022 National Annual Fund Co-Chairs establish scholarship endowments

Wanda Polk Bankhead '80 and Craig Loundas '81-'83M had great success volunteering as National Annual Fund Co-chairs during the 2020-21 and 2021-22 fiscal years. During their first year as co-chairs, they and their leadership team raised more than \$3 million dollars for the first time in SU Foundation history.

Now they are giving back to their alma mater by establishing scholarships that align with their experiences as Shippensburg University students.

The Charlie and Wanda (Polk) Bankhead College of Business Scholarship will support students enrolled in a program administered by the John L. Grove College of Business. Wanda earned a BSBA in Behavioral Management from Shippensburg and spent her career working for Allstate Insurance Company for 31 years before retiring as market claims manager.

Because of the many opportunities she received as a student in the Act 101 Program (now Academic Success Program) her scholarship will support underrepresented students with financial need. "I wanted to help others have the same experience I did."

Her scholarship recipients are also encouraged to take part in extracurricular activities. Wanda was a peer counselor and member of the Afro-AM organization, Minority Affairs, and Delta Sigma Theta Sorority. "Extracurricular activities give new students the opportunity to meet people. It helps set your priorities as you manage your time and can

influence your career path."

Craig's career path was influenced by his experience as a resident assistant in Mowrey Hall. That is why the Loundas Family Scholarship will support a resident assistant (RA) at Shippensburg. After earning his BS in Communication/Journalism, Craig went on to earn a MS in College Student Personnel from Shippensburg. He then began a career in student affairs culminating as dean of student life at Widener University.

"As I considered what area I could impact with this scholarship, I realized I was most impacted by my RA experience," Craig said, describing it as the best job of his life. "It shaped who I was, and my career." He shared his desire to create an RA scholarship with the Foundation staff not knowing if it was possible. "I would tell anyone thinking about a scholarship, 'Don't limit yourself. Ask.'"

Craig did not limit himself to a student affairs career. He received a PhD in Organizational Development from Temple University and launched a second career in that field. He retired as Associate Vice President at Penn Medicine, University of Pennsylvania Health System.

Wanda and Craig are serving together again, this time as members of the SU Foundation Board of Directors, plus they continue to play a vital role as members of the Annual Fund Leadership Team. These are just a few of the stories shared by donors who were inspired to make a major gift because they valued the great education they received at Ship. We hope you are as inspired by their stories as we are.

Bill and Carol's Story

Bill and Carol Schleig made good use of their Shippensburg degrees in education. The pair taught for a combined 60 years in Harrisburg schools. Now they want to help future teachers with the William R. and Carol O'Brine Schleig Educational Scholarship.

"We wanted to give back to the university," Carol said about the scholarship that will benefit students enrolled in a program within the College of Education

and Human Services. "It's unbelievable how much money kids today need for education."

Bill and Carol earned bachelor's and master's degrees in education from Shippensburg, Carol in 1966 and 1969, and Bill in 1970 and 1974.

Although they are only two years apart in age, Bill's education was delayed when he was drafted into the US Army during the Vietnam War. He served his country 27 years before retiring from the US Army.

Bill and Carol are natives of Harrisburg and returned there to teach in the Harrisburg School District. Carol taught both elementary and gifted education in the district for 33 years. After she retired, she supervised student teachers at Penn State Harrisburg. Bill taught math and was a guidance counselor in the Harrisburg School District for 27 years. He also taught math at Harrisburg Area Community College for 20 years.

Despite growing up in the same school system, attending the same college, and teaching in the same school district, the two did not meet until attending a teachers' meeting in 1984. They were married in 1989. They enjoy time with family including Bill's two sons, two grandsons, and two great-grandchildren.

Academic Scholarships Bright Futures College of Business Scholarship

This scholarship is for a full-time, first-year student pursuing an undergraduate degree administered by the John L. Grove College of Business. Recipients must have a minimum GPA of 2.8 and demonstrate financial need. The scholarship may be retained for a total of four consecutive academic years provided the recipient meets all retention criteria.

Patricia Nordine Burkhart Scholarship

This scholarship is for a current undergraduate student who has earned a minimum of 60 credits prior to benefiting from the scholarship. Recipients must be pursuing an undergraduate degree in biology with a concentration in pre-medicine or pre-veterinary medicine and reside in Pennsylvania.

Judy K. Fogelsonger Scholarship

This scholarship is for full-time, first-year students pursuing an undergraduate degree administered by the John L. Grove College of Business. Recipients must have a minimum GPA of 3.0 and demonstrate financial need. First preference will be given to students who are first in their immediate family to attend college. The scholarship may be retained for four consecutive academic years provided the recipient meets all retention criteria.

Kappa Lambda Chapter of Kappa Sigma Fraternity Endowed Scholarship

This scholarship is for current students who are members in good standing of the Kappa Lambda Chapter of Kappa Sigma Fraternity.

Loundas Family Scholarship

This scholarship is for a current student who is serving in at least their second semester as an undergraduate resident assistant. Recipients must have a minimum GPA of 2.8 and demonstrate financial need.

Mr. and Mrs. Milton K. Morgan III Engineering Scholarship

This scholarship is for full-time, first-year students pursuing an undergraduate degree in engineering administered by the Milton and Doreen Morgan School of Engineering. Recipients must have a minimum GPA of 3.0. The scholarship may be retained for four consecutive academic years provided the recipient meets all retention criteria.

Dr. Donna T. Motilla College of Business Scholarship

This scholarship is for entering first-year students pursuing an undergraduate degree administered by the John L. Grove College of Business. Recipients must have a minimum GPA of 3.2. The scholarship may be retained for four consecutive academic years provided the recipient meets all retention criteria.

William R. and Carol O'Brine Schleig Educational Scholarship

This scholarship is for entering full-time, first-year students pursuing an undergraduate degree administered by the College of Education and Human Services. Recipients must have a minimum GPA of 2.8 and demonstrate financial need. The scholarship may be retained for four consecutive academic years provided the recipient meets all retention criteria.

Dr. James L. Sieber Computer Science Scholarship

This scholarship is for entering full-time, first year students majoring in computer science or computer engineering. Recipients must have a minimum GPA of 3.0. This scholarship may be retained for four academic years provided the recipient meets all retention criteria.

Allan and Janice Warsing Scholarship

This scholarship is for entering full-time, first-year students. First preference will be given to students graduating from Tussey Mountain High School, and second preference will be given to students residing in Bedford County, Pennsylvania. Recipients must have a minimum cumulative GPA of 2.8 and demonstrate financial need. The scholarship may be retained for four consecutive academic years provided the recipient meets all retention criteria.

Wentz Family Scholarship

This scholarship is for entering full-time, first-year students pursuing an undergraduate degree. The recipient must be accepted into the Wood Honors College and demonstrate financial need.

Athletic Scholarships Collier-Walker Cheerleading Scholarship

This scholarship is for a student who is a member in good standing of the Shippensburg University cheerleading squad. The recipient must meet all applicable Shippensburg University athletic standards and regulations. The recipient should also demonstrate good character and citizenship while maintaining a positive attitude and a spirit of school pride as a Shippensburg University student and member of the Shippensburg University cheerleading squad.

Drs. Richard D. Stone and Mary M. Graham Men's Basketball Scholarship

This scholarship is for students who are members in good standing of the Shippensburg University men's basketball team. First preference will be given to students enrolled in any degree program administered by the John L. Grove College of Business.

Like many Shippensburg students, Olivia Hartlaub was on her own to pay for college. Scholarships helped lighten her financial burden and eventually led her to full-time employment when she graduated in May.

An accounting major in the John L. Grove College of Business, Olivia applied for the Smith Elliott Kearns & Company LLC (SEK) scholarship even though she was only a first semester sophomore. "The scholarship included an internship, and I wasn't sure they would accept an intern without more classroom experience," she said.

Olivia was awarded the scholarship and interned at the SEK office in Carlisle during tax season that spring and the next. For her senior year, Olivia broadened her experience with an auditing internship at the Hanover SEK office. "My internships opened my eyes to corporate business and better prepared me for the workforce."

She also received the Robert L. and Kathy E. Engle College of Business Scholarship and the Doug and Angela Besch Accounting Scholarship. "The scholarships made it possible for me to comfortably complete college. Knowing that someone was supporting me financially made me work all the harder," she said.

Nate's Story

Nate Hallman was working toward his degree in Early Childhood/Elementary Education when a faculty member invited him to join her research project focused on engaging children in reading. What he learned will carry into his teaching career.

Nate partnered with Dr. Laurie Cella, associate professor of English, during summer 2022 to investigate how themed reading affects children's overall learning. "Since the COVID pandemic began, we have seen a significant decline in children's reading and writing levels," Nate stated.

They worked with children in the community's Summer Learning Program, which provides two healthy meals and offers literacy-themed programming to children ages six and up. That summer, the theme was Harry Potter. Nate summarized his project, "In short, can Harry Potter make children like to read again after educational losses they have suffered during COVID?"

A grant from the Raymond and Suzanne Adams Research Endowment for Education supported the project which utilized pre- and post-surveys and focus groups. Nate said key factors he learned were "how important it is to incorporate fun and enriching learning experiences" and "how themebased learning helps to increase literacy levels and learning opportunities for every student."

Nate graduated in May with a BSEd in Early Childhood/Elementary Education PreK-4. Jacey said she considered it a great learning opportunity to work with Dr. Curt Zeleski, professor of chemistry, on his research titled "Circularly Polarized Luminescence Studies of Lanthanide-Aluminum Metallacrowns." "I got to know my professors outside of the classroom and talked with them about their passion for chemistry."

She also learned she has the capacity to speak in public. "Public speaking has never been one of my strengths, but I found I was able to explain the scientific aspects of my research in a way that people understood" at the university's Minds@ Work conference in April. A grant from the David and Anne Atkinson College of Arts and Science Research Award supported this project.


Casey's Story


Stephanie's Story

About the fund: The Student Emergency Fund was established with donor contributions to the SU Foundation to assist students who have immediate financial needs that directly affect their ability to continue their education at Ship.

The fund is open to all students with priority given to students with the highest financial need. A maximum amount of \$500 may be requested each semester. Financial assistance may include textbook and/or course-related materials, tuition, food, student housing, or other needs.


Understanding Direct and Indirect Support: Direct support is dollars that are restricted by the donor for a specific purpose and are spent on behalf of the University, at the direction of a University releasing agent (Dean, Department Chair, Director, etc.). The exceptions to restricted dollars in this category are the grants awarded to the University from the SU Foundation Board of Directors at the request of the President of the University. Indirect support is dollars that have been added to the principal of an endowment for the benefit of the students, programs, and faculty at the University, and are restricted by the donor for a specific purpose.



Over the past 10 years, funding from the SU Foundation to support students, faculty, and programs at Shippensburg University totaled \$57,973,512




